SUBJECT: ESTIMATING IP65 REVENUE ALLOCATION FOR THE 2017-18 ACADEMIC YEAR

Data description and calculation methods

The draft fiscal impact statement on IP65 from Oregon's Financial Estimate Committee (FEC), indicates that IP65 would require the state to allocate \$147 million annually for Oregon school districts to spend on programs described in IP65 (i.e., dropout prevention, career technical education, and accelerated college credit). The initiative further stipulates that the state allocate this revenue to districts based on each district's extended weighted average daily membership (extended ADMw) "computed as provided in ORS 327.013 (1)(c)".

Table 1 illustrates how the \$147 million would be distributed across districts assuming distribution of extended ADMw is the same as in the 2014-15 academic year. The table combines the 88 districts with the smallest estimated extended ADMw for grades 9-12. Together these districts account for 5% of the statewide total.

We calculate these estimates as follows:

- 1. Allocate 1.5 percent of the total (\$2,205,000) to Oregon Department of Education for administration, leaving \$144,795,000 to allocate to districts.
- 2. Calculate the total extended ADMw for grades 9-12 across all districts using estimates for 2014-15.²
- 3. Allocate to each district a share of the \$144,795,000 in proportion to that district's share of total extended ADMw for grades 9-12.

These estimates are preliminary:

- The FEC's \$147 million annual allocation estimate is not a draft and may change.
- Updated estimates based on 2015-16 extended ADMw, and actual allocations based on extended ADMw for subsequent years may lead to a different distribution.
- Differences between these estimates and the actual distribution if IP65 becomes law are likely to be larger for small districts due to natural variation in enrollment and student demographics.

¹ The allocation could be lower if state revenues do not reach thresholds identified in IP65.

² Estimates provided by ODE. The estimated high school extended ADMw equals total 2014-15 ADM for grades 9-12 multiplied by the ratio of the districts 2014-15 extended ADMw for grades K-12 to total ADM for grades K-12.
